#### I Introduction

The Institute of Development Studies Kolkata (IDSK) is now ten years old. It was promoted by the Government of West Bengal as an autonomous centre of excellence in social sciences and founded in 2002 as a society with an autonomous governing body, Professor Irfan Habib as President, Professor Amiya Kumar Bagchi as Director and with a Governing Council on which were represented the current or former Vice-Chancellors of two leading Universities in West Bengal, namely Calcutta University and Jadavpur University. The new Governing Council was constituted in 2010 with Professor Prabuddha Nath Roy as President, Professor Amiya Kumar Bagchi as Director, Professor Asis Kumar Banerjee as Secretary and Professors Sabyasachi Bhattacharya, Atis Dasgupta, Subimal Sen, Ratan Khasnabis, Abhijit Chowdhury and Sarmila Banerjee as other members.

The IDSK is devoted to advanced academic research and informed policy advice in the areas of literacy, education, health, gender issues, employment, technology, communication, human sciences and economic development. Other programmes include training of research scholars in the social sciences working towards an M.Phil or Ph.D. The Institute is committed to the dissemination of its research findings through workshops, seminars, publications in the media, and other public counselling and education programmes

During the ten years of its existence, IDSK has made its mark in the world of research in social sciences and humanities in West Bengal and Eastern India. It has actively collaborated with the departments of history, economics, political science, philosophy, business management, the Science College, and the Centre for Urban Economic Studies and Women's Studies Research Centre, and most frequently, with the Centre for Social Sciences and Humanities, of Calcutta University. The Institute has also organized a number of training and research programmes, generally in collaboration with other academic institutions, the details of which have been given in the body of the report.

The University Grants Commission(UGC) has sponsored the setting up of the Rabindranath Tagore Centre for Human Development Studies(RTCHDS) under the auspices of the IDSK

through the University of Calcutta. An Advisory Committee has been constituted with the Vice-Chancellor of the University of Calcutta as Chairman, the Director of IDSK as Vice-Chairman and with other representatives from the IDSK and the University of Calcutta. The Committee has formulated certain guidelines for the functioning of the (RTCHDS). The academic scheme of the Centre includes a programme for Ph.D students, post-doctoral fellows and visiting academics at various levels. During the three year of its existence, there were six visiting professors at the Centre. They were Dr. Ajit Banerjee, President, Centre for Ecological Culture and member of Biodiversity Board, West Bengal, Professor Ashwani Saith of Institute of Social Studies, The Hague, The Netherlands, Professor Buroshiva Dasgupta, former Director of Manipal Institute of Communication, Professor Sudhir Chakravarti, noted expert on Bengali folk music and culture, Professor Arup Maharatna of Gokhale Institute of Politics and Economics and Professor Dipankar Coondoo, former Professor of the Indian Statistical Institute, Kolkata. Post-doctoral fellows Dr. Debarati Bandyopadhyay, on leave from Visva Bharati University, Dr. Subhasri Ghosh and Dr. Gorky Chakraborty, on leave from Doom Dooma College, Assam, Professor Sujata Mukherjee on leave from Rabindra Bharati University, Dr. Utsa Ray and Dr. Joysankar Bhattacharya have joined the Centre. Dr. Debarati Bandyopadhyay and Dr. Subhasri Ghosh have completed their dissertations.

To celebrate the 150<sup>th</sup> birth anniversary of Rabindranath Tagore, the RTCHDS has constituted a Sub-committee comprising Professor Sankha Ghosh, the eminent poet and recognized authority on studies of Rabindranath Tagore, as the Chairman and Professor Sudhir Chakravarti, the noted expert on Bengali music composed by Tagore and other great song writers, and on folk religions and folk music, Professor Bhaskar Chakraborty, Department of History, University of Calcutta, Professor Syamal Chakrabarti, scientist with a wide interest in cultural issues, Professor Karuna Sindhu Das, Vice-Chancellor, Rabindra Bharati University, Professor Udaya Narayana Singh, Director, Culture and Cultural Relations, Visva Bharati University and Professor Indra Nath Choudhuri, former Secretary of Sahitya Akademi and Academic Director, Indira Gandhi National Centre for the Arts, New Delhi, as members and Professor Amiya Kumar Bagchi as Convenor to advise the Academic Committee of the Centre.

On 10 May 2011, *Rabindranath: BakpatiBiswamana*, *Vol.I*, edited by Sudhir Chakravarti and published by RTCHDS was released by poet Sankha Ghosh (Chairman of the Committee of RTCHDS) to celebrate the150th birth anniversary of Rabindranath Tagore. A cultural programme was held followed by the book release programme. Sudhir Chakravarti, Honorary Professor, RTCHDS, and Amiya Kumar Bagchi, Director, IDSK and Coordinator, RTCHDS were also present on the occasion.

On 11 August 2011, *Rabindranath: Bakpati Biswamana, Vol.II*, edited by Sudhir Chakravarti and published by RTCHDS was released by Sabyasachi Bhattacharya, former Vice-Chancellor, Visva Bharati University and it was presented to poet Nirendranath Chakraborty, chief guest of the programme. P.N. Roy, President, IDSK, presided over the programme. Sudhir Chakravarti, Honorary Professor, RTCHDS, Asis Kumar Banerjee, Secretary, IDSK and Amiya Kumar Bagchi, Director, IDSK and Coordinator, RTCHDS were also present on the occasion.

From 11 to 13 August 2011, the RTCHDS organized an international conference on Rabindranath Tagore in the World. This conference was intended to celebrate the 150<sup>th</sup> birth anniversary of Rabindranath Tagore by opening up new critical and historical approaches to putting Tagore back in the larger contexts of creative and intellectual cosmopolitanism, which he himself helped to create as an essential element of his own understanding of modernity. The general aim of this conference was to open up as many new ways of 'deprovincializing' Tagore as possible, and of setting new benchmarks in scholarly, critical, historicist, creative, performative and pedagogic practice around a figure, the full measure of whose modernity, cosmopolitanism and multifarious relevance has perhaps not been taken yet. #### II Research Programmes

# A. Improving Health Status of Women and Institutional Delivery of Public Reproductive Health Services in Rural West Bengal (Phase-2)

The project on 'Improving health status of women and institutional delivery of public reproductive health services in rural West Bengal' sponsored by the Rosa Luxemburg Foundation, Berlinaims to assess the level of contraceptive knowledge, factors determining contraceptive method choice, extent of gender inequality in contraceptive decision making, prevalence of contraceptive morbidity and associated treatment seeking behaviour among marginalized sections living in underdeveloped region of West Bengal. About 1300-1400 respondents from 45 villages of 3 blocks were selected in Birbhum district of West Bengal through multistage sampling procedure. Since utilization of traditional contraceptive method has been found to be higher in the state of West Bengal compared to all-India level, special emphasis will be given to understand the factors associated with the preference for using such methods. Besides, to understand provider's perspective on the issues related to contraceptive supply, contraceptive counselling, informed method choice and contraceptive uses will also be explored by interviewing around 50 grassroot level healthcare and contraceptive providers.

The project has started from January 1, 2012 and will be continued up to December 31, 2012. The result will be disseminated during end of the project.

#### B. The project on 'Documents on the Economic History of British Rule in India 1858-1947'

The Indian Council of Historical Research (ICHR) has appointed Professor Amiya Kumar Bagchi General Editor of the project of compiling the basic documents on the economic history of India under British rule and Professor Arun Bandyopadhyay, Nurul Hasan Professor of History, Calcutta University, Associate Editor of the project. In this project, economic history is taken in the widest possible meaning of the term, covering data and developments judged significant for the economic, social, legal and ecological history of the country. Under the joint direction of the General and Associate Editors and the work of a team of research assistants, the documents for Eastern India covering the period 1860s-1870s have been collected in a volume that was published by Manohar and released at IDSK on 31 March 2009. A second volume containing documents related to Eastern India during the 1880s and 1890s has been published by Manohar in 2011. The third volume, containing documents relating to Madras Presidency under British Rule during the 1860s and 1870s has been sent to ICHR and is expected to be published soon.

Under the direction of Professor Amiya Kumar Bagchi as General Editor of 'Documents on the Economic History of British Rule in India 1858-1947', Dr. Bhubanes Misra was appointed as Editor in charge of the final volumes of railway documents. The fourth volume of the railway construction in India during 1858-1947 was published in October 2009. A fifth volume containing documents relating to Indian participation in railway affairs has been sent to ICHR in February 2012.

#### C. The Project on "History of Girls' Schooling and Education in Bengal: 1900-1950"

The IDSK has undertaken a research project on 'History of Girls' Schooling and Education in Bengal: 1900-1950' to commemorate Begum Rokeya's pioneering efforts to advance women's education begun a hundred years ago in this city. As a part of this project, the IDSK has selected eight girls' schools of Kolkata, for recording their history. The project has been

completed and reports have been submitted by the end of 2011. The names of the scholars and the schools on which they carried out their studies are given below:

#### D. A Study of the Disability Movement in India: Trajectory, Tensions, Future

The primary aim of this study is to examine and explore the ways in which the local/regional/national struggles of groups of persons with disabilities is taking the shape of a social movement that seeks to alter the ways in which disabled people are viewed and treated by the society at large. The research study proposes to examine the different strands of the localised disability advocacy struggles in various parts of the country in order to gain a better and contextualised understanding of the key issues, important events and strategies being used to carve out a disability rights movement, based on development of collective identity for all persons with disability.

The objectives of the research are:

- To gain a deeper understanding of the processes through which alliances of persons with disabilities are being forged at the local levels the reasons and ways in which agencies are promoting formation of disabled people's organisations at the grassroots level, the reasons why disabled people are forming groups, and the ways in which they are organising themselves.
- To explore the processes by which the groups are identifying key issues as concerns for their advocacy, the strategies used by these groups to negotiate the major challenges they face in terms of inclusion in the community in terms of education, health and livelihood as well as in other domains of social life.
- To evaluate the extent of impact the efforts of these groups has had on the lives of persons with disabilities in terms of changes in structures, systems and processes, and to

determine their role in stimulating the disability rights movement at the local, regional and national level.

• To gain a deeper understanding of the processes of identity formation and reinforcement of certain identity markers for persons with disabilities brought about by the participation in the groups and in the larger movement.

Data collection in Orissa, Jharkhand, Nagaland, Meghalaya, West Bengal, Tamil Nadu, Andhra Pradesh and New Delhi has been completed. The data has been transcribed and is now being analyzed, and process of writing the report in going on.

#### E. Evaluation of the Rural Health Care Providers Training Programme

In spite of their apparent poor quality and harmful practices, the (unqualified) rural health care providers (RHCPs) are highly utilised by the rural population in West Bengal because of their easily accessible services, close contact with the community and inadequacy of the public health services in rural areas. An intervention programme has been carrying out by an NGO in the form of a year-long training programme for the last three years with the objectives of reducing their harmful practices, improving their basic knowledge related to health and health care and exploring the possibility of involving them in various public health programmes to take advantage of their close proximity with the rural community. The project titled 'Evaluation of the RHCP training programme' is an evaluation study which adopts a quasi randomised case-control design and covers 18 Gram Panchayats in three blocks of Birbhum. The project started in July 2010 and is getting over in April 2012. The baseline survey for this project was carried out in August-September 2010 and it covered 110 RHCPs, 781 households, 188 Gram Panchayat Members and 48 ANMs. The endpoint survey was carried out in August-September 2011. Between the baseline and endpoint surveys, few small scale surveys were taken up which covered 89 RHCPs, more than 350 households and some GP members as well as ANMs. In addition, many unstructured interviews have been conducted with those who were supportive of and opposing the training programme. All the data have been analysed and presentations have been made in workshops in Kolkata, Bangkok and Taipei organised by the funding agency. Dr. Rolf Heinmuller of University of Montreal, Canada who has been an advisor to this project after Dr. Slim Haddad visited Kolkata in January 2012 and spent two weeks to work on the final report of the project. A workshop for the RHCPs and the trainers was organised in Suri (Birbhum district) in January 2012 which was also attended by Dr. Heinmuller. Currently, the report is getting finalised.

#### F. Ecosystem for Life: A Bangladesh-India Initiative

It's a joint research project involving India and Bangladesh to identify the ecosystem services in the 'chars' of deltaic Bengal in both the countries and also Assam, and establish its linkage to the livelihood and well-being of the *choruas*. The project aims to reveal light on ecosystem services in the 'chars', its importance in determining and influencing the livelihood of the people, the current environmental threats in these landscapes and adaptive practices mainly depending upon and drawing from natural resources. The overall objective of the research is to increase understanding of the value of ecosystem services for maintaining environmental security. The field survey in the 'chars' of Malda and Murshidabad was conducted between September and November and the draft report has been submitted by the teams to IUCN.

# G. Adjusting to 'AILA': Climate Change, Vulnerability and Adaptation in the cyclone affected areas of the Sundarbans

This research project funded by IDSK aims to:

- Study the ecological transformation of the Sundarbans including a brief history of its geological formation, habitation, reclamation of marshes.
- Record the impact of AILA and its variation on the heterogeneous (socio-economic, ethnic, etc.) groups in the cyclone affected villages and analyze the factors behind such variation.
- Document the adaptive strategies devised and pursued by the cyclone-victims to ensure survival with special on social differentiation in adaption. Does adaptation forge another set of inequality?

The objective of the project is to address the structural core along with an understanding and narrative of adaptation/coping up as behaviour within a community.

Some preliminary data collection on cyclone in Sundarban area has already been done by Dr. Jenia Mukherjee, Co-principal Investigator. Collection of existing literature on natural disaster and its impact is in progress to build a framework of study. Consultation is in progress on selection of the study area, and will be finalized after field visit in near future.

#### H. Mainstream Migration, Scientific Diasporas and Development: Impact of Skilled Return Migration on Development in India

This project is funded by the Swiss Network for International Studies (SNIS)Federal Institute of Technology Lausanne(Ecole Polytechnique Federale De Lausanne-EPFL), Switzerland and jointly conducted by the EPFL, Switzerland and IDSK along with the Zakir Husain Centre for Educational Studies, School of Social Sciences, Jawaharlal Nehru University (JNU), New Delhi, and the International Migration Programme of the International Labour Office (ILO), Geneva, and the IRD, France. The coordinator of the project is Dr. Uttam Bhattacharya of IDSK along with the assistance of Dr. Subhanil Chowdhury and Dr. Zakaria Siddiqui of IDSK. The project has started from January 2011 and its duration is two years.

The objectives of the study is to gather information on the skilled return migration in India and study its impact on development in the country of origin; to explore strategies and measures to retain the skill; to formulate a policy oriented brain gain plan. The study covers five Cities in India. The field based survey is going to be completed by April 2012. Given the current status of the research project, so far, the research plan and schedule correspond to the original proposal as was accepted by the SNIS.' Intermediate research findings were discussed in the Workshop held at the IDSK from 5 to 9 March, 2012. Next meeting will be held in New Delhi in November 2012, to present the updated findings of the project. A proposal was accepted to prepare several joint research papers on the research findings.

#### III Collaborations

#### a. Collaboration with the University of Calcutta

In 2006, IDSK launched a multidisciplinary M.Phil programme in Development Studies, in collaboration with the Centre for Social Sciences and Humanities (CSSH), University of Calcutta. The M.Phil degree is conferred by the University of Calcutta. The first four batches of M.Phil students (2006-08, 2007-09, 2008-10 and 2009-11) successfully completed their course and obtained their degrees. The fifth batch is busy in completing their dissertations and the sixth batch is doing their coursework. The teaching faculty mainly consists of the IDSK faculty and the University faculty. The details of the M.Phil programme are provided in the next section.

#### b. Collaboration with Monash Asia Institute, Monash University, Australia

The IDSK has entered into active collaboration with Monash Asia Institute in February 2011 for five years. Under this agreement collaboration will be made in exchanging scholars, students, and academic materials, organizing cooperative seminars, workshops and other academic activities and holding joint research activities.

#### c. Collaboration with Monash Sustainability Institute, Monash University, Australia

The IDSK has entered into active collaboration with Monash Suatainability Institute in areas of public health and environmental studies with particular reference to climate change. Under this programme A two-day workshop on 'Managing Community Development in Response to Climate Change in the Ganga Basin' supported by AusAID was held in Kolkata at the ITC Sonar Bangla on 12 and 13 March 2012.

#### d. Collaboration with University of Siena, Italy

Memorandum of Understanding has also been signed with the Faculty of Economics, University of Siena, Italy in December 2008. This agreement will be valid for five years. The areas of collaboration will cover exchanging research and teaching activities, faculty and students associated with the doctoral programme of Economics.

#### e. Collaboration with Swiss Network for International Studies (SNIS)

A Memorandum of Understanding between IDSK and the Swiss Network for International Studies (SNIS) has been signed in November 2010 for carrying out a project on 'Migration, scientific diasporas and development: Impact of skilled return migration on development in India'. The duration of the project is two years.

#### f. Collaboration with Roma Tre University

IDSK and Roma Tre University have entered into a collaborative agreement in July 2011 for three years. Under this agreement cooperation will be carried out in exchanging faculty members and researchers, scientific materials and other information, drawing up common study programmes aiming at joint degrees, participating in seminars and academic meetings and holding interdisciplinary and joint research or training programmes promoted by European Commission or by other bodies or foundations.

#### j. Collaboration with Institute of Applied Manpower Research

The IDSK has signed a collaborative agreement with Institute of Applied Manpower Research, New Delhi (attached to Planning Commission, Government of India) in March 2012 for a study on 'Factors Impacting Non-agricultural Employment Growth in West Bengal'.

# IV Teaching and Research Guidance

#### M.Phil in Development Studies

The M.Phil. Programme in Development Studies is multi-disciplinary in nature, and designed to provide an understanding of various perspectives on development issues, through a rigorous course work and guided research. The perspectives are drawn from different disciplines, with a strong emphasis on the classics in social sciences and humanities. The curriculum emphasizes a heterodox perspective on social science paradigms and the

methodological underpinnings of social science research. The strength of the course particularly lies in the balance it maintains between theory and hands-on training on tools of analysis – both quantitative and qualitative.

The duration of the entire programme is two years – equally divided between coursework and writing dissertation. The first year of course work is further divided into two halves. The first half deals with the core courses, which all the students have to go through, and the second deals with the specialization courses distinguished by a few select disciplines. On completion of the first semester of course work, each student is to specialize in one of the following disciplinary areas: literature and cultural studies, economics, sociology, history and political science. The specialization courses, irrespective of the disciplinary area, will have a strong emphasis on development-oriented topics. By the end of the first year, students will choose their dissertation topics and start working under the close supervision of the faculty.

# V Conferences, Seminars and Workshops

A two-day seminar on **Invoking Ambedkar** – **Contributions, Receptions, Legacies** was held at the Salt Lake campus of Institute of Development Studies Kolkata (IDSK) on 11 and 12 March 2011. The aim of the seminar was to discuss the vast literature of Dr. B.R. Ambedkar's life, politics and scholarship and his understanding of Indian history, society, politics, economy and culture by dividing it into three broad thematic spectrums-Contributions, Receptions and Legacies. *Contributions*, reflected concerns pertaining to his life, political activities, speeches and writings, which, between them, had inspired Ambedkar himself, and his followers and other scholars, to come up with new insights and perspectives on Indian society, politics, economy and culture. The second broad thematic spectrum, called *Receptions*, included papers on the impact of Ambedkar, during his lifetime and especially

over the half century since his premature death. The third thematic spectrum, *Legacies*, sought to explore new perspectives on Ambedkar and his contributions and receptions, primarily looking to sketch the outlines of a new range of theoretical perspectives and empirical initiatives.

IDSK organized a two-day national conference on **Potential of Diverse Biodiversity Conservation Practices/Approaches and Livelihood Concerns in India** on 15 and 16 March 2011. The aim of the conference was to bring academics, NGOs, scholars, decision makers and protected area(PA) inhabitants to the debate so as to enrich the collective understanding on how to conserve forest resources and promote livelihood, to identify areas and measures to advocate policy and programmatic action as well as to guide future research. The discussion was divided into sub themes: (1) Issues on biodiversity and problems of relocation of people or coexistence of people in India; Issues if PAs are replaced by all forests considered as an integral part of biodiversity conservation with landscape approach; (2) Understanding existing conservation and development strategy: problems and prospects; State's role; Possible way out / remedial measures; (3) Required changes of policies, rules and regulations to improve the present scenario or for changes to 'co-existence' or 'landscape management' for biodiversity conservation; (4) Open Forum for discussion and resolves.

A two-day multi-disciplinary conference on *Pratyaha*: Everyday Lifeworld was organized by IDSK on October 20 and 21, 2011 to explore the everyday life process that is slowly gaining ground in the Indian social sciences. The conference focussed on 'everyday' lives or the site for common sense and common place. The Conference stressed that there are varied theoretical/ideological positions from which everyday phenomena are examined, choice of methodology and the sites of everyday practices and experiences. The conference was jointly organized by Professor Prasanta Ray and Dr. Nandini Ghosh.

On 20<sup>th</sup> October, the inaugural session of the conference began with a welcome address by Professor Amiya Bagchi, Director IDSK followed by an introduction to the conference by Professor Prasanta Ray. The keynote address of the conference was delivered by Professor Sabyasachi Bhattacharya. In the first session, the theme Food was elaborated through 3 papers that upheld food practices in Bengal, two from a qualitative perspective and the last

from a quantitative perspective. The session on Literature explored a range of topics from children's literature to Islamic writings to contemporary Bengali literature. The session on Ordinary Lives illuminated the everyday lives of people from different walks of life that included a manager, a factory worker and a litigant.

In the session on Women, the three papers delved into the everyday lives of Anglo Indian Women and the domestic help in Kolkata, as well as women whose lives were understood and read through their memoirs. The session also had papers on discrimination against the girl child and exploration of the life world of the modern day woman. In the session on Negotiations, the papers explored different themes ranging from poverty in mainstream cinema to the cult of the popular goddess and everyday lives of persons with disabilities. Finally in the session on Philosophical reflections on everyday life worlds, the paper explored spiritual pragmatism and its engagement with different levels of theory and practice.

IDSK organized a conference on Reproductive Morbidity and Treatment-seeking Behaviour in India: The Role of Demographic, Socio-economic and Cultural Correlates on 15 and 16 December 2011. Reproductive morbidity refers to all types of gynaecological and obstetric morbidities during and outside the childbearing period. This conference threw light on various dimensions of socio-economic, demographic and cultural issues of reproductive morbidity in general and gynaecological and obstetric morbidity in particular and associated treatment seeking behaviour by drawing academicians, researchers from various disciplines such as public health, medicine, demography, economics and sociology as well as health administrators, policy-makers, bureaucrats, policy makers and health providers. ## VI Library

The **Library** began functioning from December 2002. It houses an impressive number of books, journals and magazines and primary documents focussing on various development research like Development Studies, Demography, Education, Public Health, Economics, Sociology, Political Sciences, Gender Studies, Anthropology, Ethnography, Environmental studies, Human Sciences and Globalization. It has a total collection of 11226 (processed) books till 25<sup>th</sup> March 2012. The library also subscribes to 78 foreign journals among which 29 are online journals and 42 Indian journals among which 4 are available in both print and online format and 1 has only online access. It also receives complementary copies of 19 more journals. The library has acquired 309 government and 144 other reports and 210 documents published from World Health Organization. It has acquired 346 non-book materials such as Compact Disc, Digital versatile Disc, Microfilms, Maps, Audio cassettes etc. documents which are also accessioned. The library also contains the archives of Rosa Luxemburg projects which include reports, booklets, posters, pats or scroll paintings, CDs, DVDs, audio cassettes, catalogues, transparencies and fact sheets. The library acquired 3473 books out of which 351 no. of e-books purchased perpetually from Cambridge University Press and subscribes 5 foreign journals for Rabindranath Tagore Centre for Human Development Studies.

Library has purchased different tools for processing the documents e.g. Dewey Decimal Classification (DDC)  $22^{nd}$  and  $23^{rd}$  edition, Universal Decimal Classification, Standard edition, Anglo American Cataloguing Rules (AACR-2R), Sears list of subject headings  $17^{th}$  and  $20^{th}$  edition, C.A. Cutter's 3-figure Author table fully revised edition, American Library Association (ALA) filing rules. Library maintains an authority file.

The Library has established network connections with DELNET and is a member of Calcutta University's E-Journals under UGC INFONET Programme, Indiastat.com, Prowess, Capital line plus, Oxford e-bundle journals in economics, EPW online and Sage online for selected journals. Library is the institutional member of American Information Resource Centre Kolkata, Indian Statistical Institute Kolkata and The National Library.

The library is using SOUL version 1 (Software for University Libraries) for its on-going automation activities. Currently the library has entered and processed 11226 documents in SOUL. Library has also started book charging and discharging with the help of SOUL SOFTWARE since January 2011. Users are getting benefit of that.

The Institute has been gifted with very valuable collections, that of the late Michael Sprinker, a leading radical literary theorist, Shri Gopal Krishna Gandhi, Governor of West Bengal, and also a collection of about 1900 books from Shri Parimal Dasgupta, a leading journalist. These two gifts have been designated as the *Michael Sprinker* and *Parimal Dasgupta Collections* respectively.

The library is extending its service to outside research scholars, faculty members. Many visitors from India and outside India are visiting the library regularly. Information regarding the library has been incorporated in the website of IDSK (<a href="www.idsk.edu.in">www.idsk.edu.in</a>).
