I Introduction

The Institute of Development Studies Kolkata (IDSK) is now eleven years old. It was promoted by the Government of West Bengal as an autonomous centre of excellence in social sciences and founded in 2002 as a society with an autonomous governing body, Professor Irfan Habib as President, Professor Amiya Kumar Bagchi as Director and with a Governing Council consisting of the current or former Vice-Chancellors of two leading Universities in West Bengal, namely Calcutta University and Jadavpur University. The new Governing Council was constituted in 2010 with Professor Prabuddha Nath Roy as President, Professor Amiya Kumar Bagchi as Director, Professor Asis Kumar Banerjee as Secretary and Professors Sabyasachi Bhattacharya, Atis Dasgupta, Subimal Sen, Ratan Khasnabis, Abhijit Chowdhury and Sarmila Banerjee as other members. On expiry of the tenure of Professor Amiya Kumar Bagchi as the Director on 11 October 2012, Professor Asis Kumar Banerjee assumed the charge as the Officiating Director of the Institute.

The IDSK is devoted to advanced academic research and informed policy advice in the areas of literacy, education, health, gender issues, employment, technology, communication, human sciences and economic development. Other programmes include training of research scholars in the social sciences working towards an M.Phil or Ph.D. The Institute is committed to the dissemination of its research findings through workshops, seminars, publications in the media, and other public counselling and education programmes. During the eleven years of its existence, IDSK has made its mark in the world of research in social sciences and humanities in West Bengal. The Institute has also actively collaborated with the departments of history, economics, english, political science, philosophy, business management, the Science College, and the Centre for Urban Economic Studies and Women's Studies Research Centre of Calcutta University. The Institute has also organized a number of training and research programmes, generally in collaboration with other academic institutions.

The University Grants Commission(UGC) has sponsored the setting up of the Rabindranath Tagore Centre for Human Development Studies(RTCHDS)under the auspices of the IDSK through the University of Calcutta. An Advisory Committee has been constituted with the Vice-Chancellor of the University of Calcutta as Chairman, the Director of IDSK as Vice-Chairman and with other representatives from the IDSK and the University of Calcutta. The Committee has

formulated certain guidelines for the functioning of the RTCHDS. The academic scheme of the Centre includes a programme for PhD students, post-doctoral fellows and visiting academics at various levels. Details of activities of the Institute have been given in the body of the report during the year 2012-13.

II Research Programmes

A. Improving Health Status of Women and Institutional Delivery of Public Reproductive Health Services in Rural West Bengal (Phase-2)

The project on 'Improving health status of women and institutional delivery of public reproductive health services in rural West Bengal' sponsored by the Rosa Luxemburg Foundation, Berlin aimed to assess the level of contraceptive knowledge, factors determining contraceptive method choice, extent of gender inequality in contraceptive decision making, prevalence of contraceptive morbidity and associated treatment seeking behaviour among marginalized sections living in underdeveloped region of West Bengal. About 1300-1400 respondents from 45 villages of 3 blocks were selected in Birbhum district of West Bengal through multistage sampling procedure. Since utilization of traditional contraceptive method has been found to be higher in the state of West Bengal compared to all-India level, special emphasis has been given to understand the factors associated with the preference for using such methods. Besides, to understand provider's perspective on the issues related to contraceptive supply, contraceptive counselling, informed method choice and contraceptive uses were also explored by interviewing around 48 grassroot level healthcare and contraceptive providers. The project was started from January 1, 2012 and continued up to December 31, 2012. The results were disseminated during end of the project at the district level as well as at the state level.

B. Evaluation of the Rural Health Care Providers Training Programme

This evaluation study started in August-September 2011 with a baseline survey which covered Rural Health Care Providers (RHCPs) from selected areas who were not covered by the training programme of the Liver Foundation till the time of survey. The average age of the RHCPs was found about 40 years. For most of the RHCPs, medical practice was found as a main profession and for those whose main profession was different were engaged in agricultural activities

including petty business, LIC agent, compounding etc. On an average they have about 12 years of schooling and about 13 years of experience as RHCP.

The level of awareness of the RHCPs (who did not receive the training by the Liver Foundation) with regard to possible reasons for many illnesses is poor. Almost all the surveyed RHCPs (who were not covered by the training programme) expressed the need for undergoing a training programme by qualified doctors for improving their current knowledge and services, although they did not express any willingness to pay for obtaining such training. Majority of the RHCPs who were willing to join the training programme did not have well specified goals on what they expect to learn from the training programme. A significant number of them expressed goals which are not deliberately covered under the training programme.

The evaluation exercise using semi-randomised experimental design shows that RHCPs who underwent the training programme (*i.e.* experimental group RHCPs) demonstrate additional empowerment over the RHCPs who did not go through the training programme (*i.e.* controlled group RHCPs) when assessed by certain indicators such as owning a clinic, less involvement in cross-practicing, average number of patients seen per day, number of home calls, remaining in touch with other RHCPs and procuring medicines directly from the dealers. The training has made RHCPs' understanding of possible reasons for illness more precise. However, the training does not seem to have improved RHCPs' understanding of doses of medicine.

In a nutshell, the training has been successful in achieving some of its objectives. However, there are few areas in which the training needs to shift its focus and emphasis on an urgent basis. Moreover, there is a need for rethinking about the criteria for coverage and selection of RHCPs as well as restructuring the course syllabus. Our evaluation study clearly finds that there is a strong demand for this training programme among RHCPs who have heard about its structure and contents. Our quantitative and qualitative analysis clearly finds that community leaders and government health workers find merits in the contribution of the training programme and they are in favour of RHCPs in their areas joining the programme.

The project report has been submitted to Bristol Myers Squibb Foundation.

C. Mainstream Migration, Scientific Diasporas and Development: Impact of Skilled Return Migration on Development in India

This two-year project is funded by the Swiss Network for International Studies (SNIS) Federal Institute of Technology Lausanne (Ecole Polytechnique Federale De Lausanne-**EPFL**), Switzerland and jointly conducted by the EPFL, Switzerland and IDSK along with the Zakir Husain Centre for Educational Studies, School of Social Sciences, Jawaharlal Nehru University (JNU), New Delhi, and the International Migration Programme of the International Labour Office (ILO), Geneva, and the IRD, France. The coordinator of the project is Dr. Uttam Bhattacharya of IDSK along with the assistance of Dr. Subhanil Chowdhury and Dr. Zakaria Siddiqui of IDSK. The project has started from January 2011.

The objectives of the study is to gather information on the skilled return migration in India and study its impact on development in the country of origin; to explore strategies and measures to retain the skill; to formulate a policy oriented brain gain plan. The study has focused on the contributions of the high skilled returnees (and the diaspora communities) from four European Countries (viz. France, Germany, Netherlands and Switzerland) to home country (India) development. The findings are based on field survey data from five cities in India and said four European countries. The project report has been submitted to the SNIS on 30 March, 2013.

D. Factors Impacting Non-agricultural Employment Growth in India

This project has been completed and the Report submitted to IAMR, New Delhi. It was based on field survey in 7 districts in West Bengal classified to suit low, medium and highly industrial concentration to identify the factors influencing non-agricultural employment growth within the state.

E. Inequality to Access to Modern Energy Services: India Case

This is an on-going project to ascertain the inequality to access to modern energy in rural areas, primarily based in Bihar and Jharkhand. Village selection has been completed and pilot survey has also been done in Deoghar district of Jharkhand. Field survey will be completed in Deoghar and Bhagalpur (Bihar) during April-May 2013.

F. Exploring means of Democratic Transformation: Theory and Practice in South Asia

IDSK and Rosa Luxemburg Stiftung (RLS) jointly implemented a project on 'Exploring means of democratic transformation: Theory and practice in South Asia' in January 2013. The purpose of the project is to systematically explore left concepts related to democratic transformation in order to examine the quality of Left politics in participation at the theoretical and practical level. The project aims to conduct a research based on available literature and interviews to arrive at a genuine definition of democratic transformation laying stress on universal suffrage and socioeconomic equality, to conduct interviews of at least 10 eminent writers and artists, sociologists, political philosophers and politicians as well as economists from Bangladesh, Pakistan and Nepal to document their thoughts and engagement which would act as a reference for practitioners of democracy, to invite at least 15 young scholars of different universities and research institutes from South Asian countries for preparing and presenting their papers in a conference cum workshop.

G. Land as Private Property: Land Relations in the Hill Areas of North East India

This is an ICSSR funded joint project with Omeo Kumar Das Institute of Social Change and Development, Guwahati, project started in January 2013. Dr. Gorky Chakraborty of IDSK is the investigator of the project. An area of scholarship is often neglected in analyzing the transformation process in North East. It deals with identifying the causes as well as understanding the process of changes in Land Relations among the hill tribes of the region. A chapter underlying the Historical aspects related to privatization of land in the hill areas is being drafted along with finalization of the questionnaire for field survey among 14 hill tribes located in the 7 North Eastern states. Field survey will commence from April 2013.

H. Documents on Economic History during British Rule in India, Northern and Western India in the Late Nineteenth Century: Quality of Life

This is a four-year project sponsored by Indian Council of Historical Research with Professor Amiya Kumar Bagchi as General Editor and Professor Arun Bandyopadhyay, Nurul Hasan Professor of History, University of Calcutta as Associate Editor. The project has commenced in March 2013.

The initial two volumes of the study will be on agriculture related aspects including productivity, land use and irrigation in Northern India in the late nineteenth century. There will be two

volumes, one related to the period 1860s-1870s and the other to the 1870s-1880s. A whole range of new questions such as exploitation of forest resources, impact of plantation and the opening of mines, siltation of rivers and disuse of tanks, the new irrigation works through civil engineering and the emerging links (non-links) of water and different groups of community, and the impact of the varying use of land on soil erosion, decline of fertility, public health, life expectation and mortality, occurrence of droughts and famines, and change in climate. Materials on non-agricultural production will also be included. It is obvious that documents relating to these subjects are to be studied from the perspectives of economic, social and environmental change under British rule.

I. Understanding Drishti: Early Indian Approaches to Ophthalmological Diseases & Treatments

Professor Ranabir Chakravarti, Visiting Professor, RTCHDS has undertaken a project *Understanding Drishti : Early Indian Approaches to Ophthalmological Diseases & Treatments* starting from July , 2010. The duration of the project was three years. The research project on Drishti (literally vision) was planned to undertake a thorough and elaborate study of ophthalmic diseases and their treatments in pre-modern India with a thrust on the early period of Indian history (up to c.AD 1300). The final report was submitted during June 2012 and an Occasional Paper was published in August 2012 from this report.

III Collaborations

a. Collaboration with the University of Calcutta

In 2006, IDSK launched a multidisciplinary M.Phil programme in Development Studies, in collaboration with the Centre for Social Sciences and Humanities (CSSH), University of Calcutta. The M.Phil degree is conferred by the University of Calcutta. Now the collaboration is between the Economics Department, University of Calcutta and IDSK. The first four batches of M.Phil students (2006-08, 2007-09, 2008-10, 2009-11, 2010-12, 2011-13) successfully completed their course and obtained their degrees. The sixth batch is busy in completing their dissertations and the seventh batch is doing their coursework. The teaching faculty mainly consists of the IDSK faculty and the University faculty. The details of the M.Phil programme are provided in the next section.

b. Collaboration with Monash Asia Institute, Monash University, Australia

The IDSK has entered into active collaboration with Monash Asia Institute in February 2011 for five years. Under this agreement collaboration will be made in exchanging scholars, students, and academic materials, organizing cooperative seminars, workshops and other academic activities and holding joint research activities.

c. Collaboration with Monash Sustainability Institute, Monash University, Australia

The IDSK has entered into active collaboration with Monash Suatainability Institute in areas of public health and environmental studies with particular reference to climate change. Under this programme a two-day workshop on 'Managing Community Development in Response to Climate Change in the Ganga Basin' supported by AusAID was held in Kolkata at the ITC Sonar Bangla on 12 and 13 March 2012.

d. Collaboration with University of Siena, Italy

Memorandum of Understanding has also been signed with the Faculty of Economics, University of Siena, Italy in December 2008. This agreement will be valid for five years. The areas of collaboration will cover exchanging research and teaching activities, faculty and students associated with the doctoral programme of Economics.

e. Collaboration with Roma Tre University

IDSK and Roma Tre University have entered into a collaborative agreement in July 2011 for three years. Under this agreement cooperation will be carried out in exchanging faculty members and researchers, scientific materials and other information, drawing up common study programmes aiming at joint degrees, participating in seminars and academic meetings and holding interdisciplinary and joint research or training programmes promoted by European Commission or by other bodies or foundations.

IV Teaching and Research Guidance

M.Phil in Development Studies

The M.Phil Programme in Development Studies is multi-disciplinary in nature, and designed to provide an understanding of various perspectives on development issues, through a rigorous course work and guided research. The perspectives are drawn from different disciplines, with a strong emphasis on the classics in social sciences and humanities. The curriculum emphasizes a heterodox perspective on social science paradigms and the methodological underpinnings of social science research. The strength of the course particularly lies in the balance it maintains between theory and hands-on training on tools of analysis – both quantitative and qualitative.

The duration of the entire programme is two years – equally divided between coursework and writing dissertation. The degree is conferred by the University of Calcutta and the programme conforms to the pattern of the existing M.Phil programmes offered by the University. The overall administration of the programme is run under the joint auspices of the IDSK and the department of Economics, University of Calcutta as per the Memorandum of Understanding between the University of Calcutta and IDSK. The teaching faculty mainly consists of the IDSK faculty and the University faculty. Eminent academicians from other institutions are also invited as guest faculty.

V Conferences, Seminars, Workshops and Lectures

National Conference on 'Money, Finance and Macroeconomics of the Real Economy'

A three-day national conference on **Money, Finance and Macroeconomics of the Real Economy** was organized by IDSK from 26 to 28 April 2012. The speakers in the conference included Professor Dilip Nachane, Former Director, Indira Gandhi Institute of Development Research, Professor Pronab Sen, Former Chief Statistician of India, Professor Partha Ray, Indian Institute of Management Calcutta, Professor Pulapre Balakrishnan, Director, Centre for Development Studies, Kerala, Professor Ratan Khasnabis, Former Professor of Business Management, University of Calcutta, Professor Pinaki Chakraborty, National Institute of Public Finance and Policy, Dr. Subir Gokarn, Deputy Governor, Reserve Bank of India, Dr. Rammanohar Reddy, Editor, *Economic and Political Weekly*, Dr. Kaushik Bhattacharya, Indian Institute of Management, Lucknow, Dr. Parthapratim Pal, Indian Institute of Management Calcutta, Dr. Pranab Das, Centre for Studies in Social Sciences, Calcutta, Dr. Rohit, South Asian University, New Delhi, Surajit Das, National Institute of Public Finance and Policy, Dr. Surajit Mazumdar, Ambedkar University, New Delhi and Professor Indrani Chakraborty and Dr. Subhanil Chowdhury of Institute of Development Studies Kolkata. Professor Amiya Kumar Bagchi, Director, IDSK delivered the inaugural speech.

Workshop on 'Planet, People or Profit? The 'Perilous Passage' and the Capitalist Transformation of the Natural World'

IDSK organised a week-long workshop on **Planet, People or Profit? The 'Perilous Passage'** and the Capitalist Transformation of the Natural World from September 10 to 14, 2012 at the Salt Lake Campus of the Institute to familiarise as well as refresh the faculty members and research scholars from the discipline of history or from other disciplines interested in environmental studies. 40 participants from different parts of the country registered in the programme. It began with the welcome address of Professor Amiya Kumar Bagchi who provided a broad outline of the entire course bringing out the inversely proportional relationship between advancing capitalism and environmental degradation. It was followed by the inaugural speech of Professor Mahesh Rangarajan. Eminent historians and environmental scientists reflected on 5 major themes (1. The Industrial Revolution and natural environment in the west, 2. Colonial capitalism and its impact on the natural landscapes of Americas, Asia, and Africa, 3.

Environment and environmentalism(s), post-WWII scenario, 4. Ecological thought (with emphasis on ecological materialism, 5. Ecological Practices) followed by case study based presentations from both the invited practitioners from the field and the participants themselves. The discussions were extremely interactive where both instructors and applicants engaged in brainstorming activities to sketch ecological alternatives for the betterment of our planet and emancipation of mankind.

Conference on 'Interrogating Disability: Theory and Practice'

A three day conference on **Interrogating Disability: Theory and Practice** was held at IDSK in order to explore the varied issues within the field of disability, from problematizing the ways in which disability is conceptualised to understanding the everyday lived experience of disabled people in a society that is largely geared for able bodied people through structures that are exclusionary and discriminatory. Delivering the welcome address on 27th September 2012, Professor Amiya Kumar Bagchi, Director IDSK spoke of the diversity of disability and impairment and the fact that all people stand the risk of becoming disabled at any point of their lives. Thus all people may be termed as TABs or Temporarily Able Bodied. Dr. Nandini Ghosh, Convenor of the Conference highlighted the fact that such academic social science conferences on disability are a rarity in India and hence it was a pleasure to be able to host such a path breaking conference at IDSK. The keynote address was delivered by Professor Anita Ghai of Jesus Mary College, New Delhi. She spoke about Disability Studies as a discipline which has been ignored by academic departments in India and relegated to the position of a marginalised and marginal area of study. She talked about the possibilities of disability studies research adding to the existing body of knowledge and theory and advocated for a robust theory of disability that can be used in the Indian context. On 29th September 2012, there was a panel discussion on *Inclusive Education: Debates and Possibilities*, which was moderated by Ruma Chatterjee. The panellists included disabled people themselves, disability activists, and teachers from mainstream and special schools that promoted inclusive education. The panellists all agreed that in the current scenario and with the legal policy frameworks inclusive education is the only mode of delivery of learning to children with disabilities. However they discussed different strategies that might be used to promote inclusive education in mainstream schools, which would lead to a better learning environment and outcomes for all children.

Workshop on 'Human Development'

IDSK organised a week-long workshop on **Human Development** from December 3-7, 2012 for teachers in colleges, universities and research institutes in eastern India, and others interested in development issues, having at least a Master's degree in any discipline from a recognized university, working in government and non-government organizations including the media. The objective was to help the participants develop adequate analytical capability to deal with development policy issues from the human development perspective, which is cross-disciplinary. Lectures referred to important studies of both theoretical and applied kind in order to provide an in-depth understanding of the issues, highlighting their contested nature. The topics included (1) Conceptual foundation, (2) Human development and national economic prosperity, (3) Issues in measurement, (4) Population dynamics and health, (5) Participation and empowerment, (6) Regional perspectives on human development in India. The resource persons included, besides the faculty of IDSK, Professor Amiya Bagchi (Emeritus Professor, IDSK), Professor S. Subramanian (Madras Institute of Development Studies), Professor Indraneel Dasgupta (Indian Statistical Institute, Kolkata), Professor Raghabendra Chattopadhyay (Indian Institute of Management, Kolkata), Dr. Manabi Majumdar (CSSSC), Mr. Kamal Pal (Director, Riddhi), Ms

Swati Bhattacharya (Chief Reporter, Ananda Bazar Patrika). Professor Sugata Marjit (Chairman, West Bengal Council for Higher Education) gave the keynote address. 56 participants registered for the workshop. Subrata Mukherjee, Saswata Ghosh and Achin Chakraborty coordinated the programme.

A day-long seminar in commemoration of Eric Hobsbawm

A day-long seminar was held on **Tribute to Professor Eric Hobsbawm** on 15 December 2012. The welcome address was delivered by Prof. Asis Kumar Banerjee and the seminar was inaugurated by Professor Tapan Raychaudhuri. Other eminent speakers included Professor Sabyasachi Bhattacharya, Professor Malini Bhattacharya, Professor Sudeshna Chakraborti, Professor Hiten Patel, Dr. Subhanil Chowdhury, and Dr. Jenia Mukherjee. A panel was organized on the *Legacy of Hobsbawm* where renowned scholars like Professor Ashok Mitra, Professor Amiya Kumar Bagchi and Professor David Washbrook shared their views.

Workshop on 'Capacity Development for Young Health Researchers in Social Sciences'

IDSK organised a week-long workshop on Capacity Development for Young Health Researchers in Social Sciences during February 4-8, 2013. The workshop was designed with the objective to include those young health researchers in social sciences who showed keen interest in research capacity development in order to have better understanding on various health issues by drawing on knowledge from relevant disciplines related to health, quantitative and qualitative tools for health research and perspectives of different stake holders in the health sector. The intended target group of this workshop was MPhil and PhD students, young faculty members in colleges, universities and research institutions working or interested in health issues, persons working in NGOs, in governments and in Media. The workshop was designed for providing the participants a broad conceptual understanding of health related issues by equipping themselves with evidence and tools from multiple disciplines and by making them familiar with the perspectives of multiple stake holders of the health sector.

The workshop began by providing the participants an overview of important health issues which were crucial in India's current socio-economic and demographic context. This was followed by sessions covering concepts and measurement of different health variables, philosophical issues in the measurement of health inequality, quantitative tools and qualitative methods health research, ethical issues in health research, development of survey instruments for health research, health

financing, evaluations of health interventions, interaction of medical and social perspectives in health research in the subsequent days. Apart from the introductory session, workshop included 15 sessions by the resource persons and 2 interactive sessions organised by the participants themselves.

The workshop relied on both internal (IDSK faculty members) as well as external resource persons (outside IDSK). The external resource persons were Professor T K Roy (former director of International Institute for Population Sciences), Mr Dilip Ghosh (former IAS, Secretary, Department of Health and Family Welfare, Mission Director, NRHM, West Bengal), Dr Abhijit Chowdhury (Professor, Institute of Post Graduate Medical Education and Research, Kolkata), Dr N Devadasan (Director, Institute of Public Health Bangalore), Professor Barun Kanjilal (Institute of Health Management and Research, Jaipur) and Dr Arijita Dutta (Calcutta University). The IDSK faculty members who participated in the workshop were Professor Amiya Kumar Bagachi, Professor Achin Chakraborty, Dr Krishna Soman, Dr Nandini Ghosh, Dr Saswata Ghosh and Dr Subrata Mukherjee. Dr Subrata Mukherjee, an IDSK faculty member with specialization in Health Economics was the coordinator of the workshop

Seminar on 'Contemporary Indian Economic Policies: Deprivation, Destitution and Debates'

IDSK in collaboration with the Forum for Development Economics Kolkata(FDEK), Department of Economics, University of Calcutta organised a two-day national seminar on 21-22 March 2013 on Contemporary Indian Economic Policies: Deprivation, Destitution and Debates and a special session on Foreign Direct Investment(FDI) in retail trade in India. The day two seminar, i.e., the special session on FDI in retail trade was held at the IDSK, Salt lake campus on 22nd March 2013. About 40 participants attended the session. VII Library

The Library began functioning from December 2002. It houses an impressive number of books, journals and magazines and primary documents focussing on various development research like Development Studies, Demography, Education, Public Health, Economics, Sociology, Political Sciences, Gender Studies, Anthropology, Ethnography, Environmental studies, Human Sciences and Globalization. It has a total collection of 11226 (processed) books till 25th March 2012. The library also subscribes to 78 foreign journals among which 29 are online journals and 42 Indian journals among which 4 are available in both print and online format and 1 has only online access. It also receives complementary copies of 19 more journals. The library has acquired 309 government and 144 other reports and 210 documents published from World Health Organization. It has acquired 346 non-book materials such as Compact Disc, Digital versatile Disc, Microfilms, Maps, Audio cassettes etc. documents which are also accessioned. The library also contains the archives of Rosa Luxemburg projects which include reports, booklets, posters, pats or scroll paintings, CDs, DVDs, audio cassettes, catalogues, transparencies and fact sheets. The library acquired 3473 books out of which 351 no. of e-books purchased perpetually from Cambridge University Press and subscribes 5 foreign journals for Rabindranath Tagore Centre for Human Development Studies.

Library has purchased different tools for processing the documents e.g. Dewey Decimal Classification (DDC) 22^{nd} and 23^{rd} edition, Universal Decimal Classification, Standard edition, Anglo American Cataloguing Rules (AACR-2R), Sears list of subject headings 17^{th} and 20^{th} edition, C.A. Cutter's 3-figure Author table fully revised edition, American Library Association (ALA) filing rules. Library maintains an authority file.

The Library has established network connections with DELNET and is a member of Calcutta University's E-Journals under UGC INFONET Programme, Indiastat.com, Prowess, Capital line plus, Oxford e-bundle journals in economics, EPW online and Sage online for selected journals. Library is the institutional member of American Information Resource Centre Kolkata, Indian Statistical Institute Kolkata and The National Library.

The library is using SOUL version 1 (Software for University Libraries) for its on-going automation activities. Currently the library has entered and processed 11226 documents in SOUL. Library has

also started book charging and discharging with the help of SOUL SOFTWARE since January 2011. Users are getting benefit of that.

The Institute has been gifted with very valuable collections, that of the late Michael Sprinker, a leading radical literary theorist, Shri Gopal Krishna Gandhi, Governor of West Bengal, and also a collection of about 1900 books from Shri Parimal Dasgupta, a leading journalist. These two gifts have been designated as the *Michael Sprinker* and *Parimal Dasgupta Collections* respectively.

The library is extending its service to outside research scholars, faculty members. Many visitors from India and outside India are visiting the library regularly. Information regarding the library has been incorporated in the website of IDSK (www.idsk.edu.in).
